Note: The mandatory disclosure in prescribed format is required to be hosted on the website or posted/forwarded in the AICTE website failing which, action would be initiated as per the rules and regulations of the AICTE including its Extension/Withdrawal of approval.

The institution is required to submit two copies of the Compliance Report, including the rectification of deficiencies along with necessary disclosure and details of faculty recruited for each course in the prescribed format (available at AICTE Website www.aicte.ac.in) to the concerned Regional Office along by 31st August 2022 for consideration of approval beyond the session.

* Compliance Report must be accompanied with a processing fee of Rs. 40,000/- in the form of demand draft in the favour of Joint Secretary, AICTE, Bhabha, New Delhi. In the absence of processing fee the Compliance Report will not be reviewed. Following the Compliance report, the Council would verify the status in respect of rectification of deficiencies through on-site random inspection without any prior notice.

The above approval is granted after rectification of deficiencies would be subject to the fulfilment of the following general conditions:

- ✓ That the management shall provide adequate funds for development of land and for providing related infrastructure, instructional and other facilities as per norms and standards laid down by the Council from time to time and for meeting recurring expenditure.
- ✓ (ii) That the admission shall be made only after adequate infrastructure and all other facilities are provided as per norms and guidelines of the AICTE.
- ✓ (iii) That the admissions shall be made in accordance with the regulations notified by the Council from time to time.

As per AICTE norms


- ✓ 10. That a computer center with suitable number of laptops, printers etc. shall be established as per AICTE norms.
- ✓ 11. AICTE may carry out random inspections round the year for verifying the status of the institutions to ensure maintenance of norms and standards.
- ✓ 12. That the AICTE may also conduct inspections with or without copying the dates to verify specific concerns of misrepresentation, violation of norms and standards, etc. problems etc.
- ✓ 13. That the institutions by virtue of the approval given by Council shall not automatically become exempted to any grant-in-aid from the Central or State Governments.
14. That in the event of student candidates withdrawing before the starting of the course, the well listed candidates should be given admission against the vacant seats. The entire fee collected from the student after a deduction of the processing fee of not more than Rs. 1000/- (Rupees One thousand only) shall be refunded and retained by the Institution/University to the student candidate withdrawing from the programme. It would not be permissible for Institution and Universities to retain the School/Institution Leaving Certificate in original to have retention of admitted students. For Public Notice AICTE/03/2000/122000.
- ✓ 15. The HM/Col shall take appropriate measures for prevention of ragging in any form, in the light of directions of Supreme Court of India in Para Position No. 6/2007/1000. In case of failure to prevent the instances of ragging by the institutions, the Council shall take appropriate action including withdrawal of approval.
16. That the Management shall strictly follow further conditions as may be specified by the Council from time to time.
17. In the event of non-compliance by the VIGNANARITA TRUST, SHIVAJIRAO S. JONDHLE COLLEGE OF ENGINEERING & TECHNOLOGY, ASANGAON, OPP RLY STATION, SHAHAPUR, THANE - 421 601 with regard to guidelines, terms and conditions prescribed from time to time, the Council shall be free to take measures for withdrawal of its approval or suspension, without consideration of any related issues and that all liabilities arising out of such withdrawal would solely be that of VIGNANARITA TRUST, SHIVAJIRAO S. JONDHLE COLLEGE OF ENGINEERING & TECHNOLOGY, ASANGAON, OPP RLY STATION, SHAHAPUR, THANE - 421 601.
